# **Our Purpose**

The Board's purpose under the *Legal Profession Act* 2007 (Qld) is to assist the Supreme Court by making a recommendation about each application for admission as a Lawyer in Queensland. In doing so, the Board considers whether an application is made under the *Supreme Court* (*Admission*) *Rules* 2004, whether an applicant is eligible and suitable for admission, and whether there are other matters the Court may consider relevant to the application.
