

# Professional Standards Scheme Exemption Application

A participating member in the Professional Standards Scheme may in the course of the practice year want or be required to be exempted from the Scheme. An example of when this might be is that the member changes employment from a practice that participates in the Scheme to one that does not.

Those who participate in the Scheme should consider carefully if they should exempt themselves in the course of the year. Taking an exemption when a member of or employed by a law practice that participates in the Scheme is likely to deny the law practice the benefit of the Scheme since it is a requirement of the Scheme that all eligible staff participate.
